



## HTC Hero £30 Voucher Promotion Terms and Conditions

### Promotional Period – 1<sup>st</sup> February to 28<sup>th</sup> February 2010

Subject to the remainder of these terms and conditions customers can claim £30 of vouchers (2 x £15 vouchers to be used on separate orders) on the following device: HTC Hero (eXpansys code: 184566) purchased between 1<sup>st</sup> February – 28<sup>th</sup> February 2010 from eXpansys. eXpansys will email the customer £30 of vouchers for a maximum of 1 device purchased during the period of the promotion no earlier than 14 days after the customer has received the product from eXpansys.
2. The promotion is valid in respect of the HTC Hero device purchased directly from eXpansys only. The promotion is only valid for end user eXpansys customers supply a UK invoicing and delivery address; claims where the products purchased will be resold or rented to a third party are ineligible for this promotion.
